### Fourth of July Fireworks Spectacular at Crowley Lake

The Town of Mammoth Lakes in partnership with Crowley Lake Fish Camp is extremely proud to host the annual Fourth of July Fireworks Spectacular at Crowley Lake on Tuesday, July 4, 2017. The Independence Day fireworks show promises to be a bright and striking display of color in the Eastern Sierra night sky. This year's "Sky Concert" will propel over 737 shells into the Eastern Sierra sky for a mesmerizing 20 minutes beginning at approximately 9:15 p.m. (weather permitting).

Funding for this year's Fourth of July show has been generously donated by Mono County Community Services Area 1, L.D.C, and from the Town's general fund, however, additional funds are still needed to produce this spectacular event. Since incorporating in 1984, the Town of Mammoth Lakes has been celebrating Independence Day with a spectacular fireworks show. The Town contracts Pyro Spectaculars by Souza to light up the sky above Crowley Lake. Souza is well known for doing some of the largest and most spectacular fireworks displays in the world.

Admission to the Fourth of July Fireworks Show is once again only \$25.00 per car, RV, or truck (excludes camping), and \$5.00 per individual/bike (walking/riding).

To ensure a safe holiday experience for everyone, please observe the following:

- No personal fireworks are permitted within Mono County, including the Inyo National Forest (INF), and Bureau of Land Management (BLM) lands. Be smart; leave the fireworks to the professionals!
- Due to EXTREME FIRE DANGER, the Mammoth Lakes Fire Protection District, Long Valley Fire Department, Mammoth Lakes Police Department, California Highway Patrol and Mono County Sheriff will enforce a "zero tolerance" policy with respect to the possession and use of fireworks. Fireworks violations will be strictly enforced.
- Please obey road closure and no parking signs. Parking is NOT permitted along Highway 395 or Crowley Lake Drive at any time. Do not park in fire lanes.
- The Mono County Sheriff's Office will be patrolling on Crowley Lake during the fireworks show. Do not boat within 100 yards of the fireworks detonation site at Hilton Bay and proper night-time navigation lighting is required.
- Help us keep Mono County clean. Please use designated trash facilities.
- Do not drink and drive. Please use a designated driver or plan to camp at Crowley Lake Fish Camp.

### **Fireworks Prohibited in the Town of Mammoth Lakes**

All fireworks are prohibited in the Town of Mammoth Lakes, regardless if "safe and sane" or not. In addition, personal use of fireworks is **prohibited** in the non-incorporated areas of Mono County, on the Inyo National Forest (INF), and Bureau of Land Management (BLM) lands.

Due to **HIGH FIRE DANGER** resulting from recent high temperatures and large anticipated holiday crowds, both the Mammoth Lakes Fire Protection District and Mammoth Lakes Police Department will enforce a "**zero tolerance**" policy with respect to the possession and use of fireworks. Fireworks violations will be strictly enforced.

Due to the wet winter that the Town of Mammoth enjoyed, there is an abundant crop of grasses all over town and throughout the county. The grass species will efficiently carry a fire quickly into other vegetative species resulting in the possibility of a well-established fire. Depending on temperature, time of day, and wind, the incident could threaten lives and property.

Enjoy and celebrate the holiday in a safe and responsible manner, and feel free to attend the scheduled Fourth of July firework shows. There will be fireworks shows on Saturday, July 1 at the summit of Mammoth Mountain, in The Village at Mammoth on Monday, July 3, and Tuesday, July 4 at Crowley Lake.

With hot temperatures, the snow at the higher elevations is melting and the creeks in the Eastern Sierras are rising. The creeks are filling their banks and in some cases overflowing and resulting in property damage. The swiftness and the cold temperature of the water, while inviting can be very dangerous. Be watchful of children, pets, and the closeness of anyone in your party to the stream channel.

Respect the velocity and strength of the streams, recognize that being in the water has the potential of being life threatening, enjoy the beauty from a distance, and stay safe.

### **Leash Your Dog – It’s The Law**

The Mammoth Lakes Police Department would like to remind citizens that the Town of Mammoth Lakes has several ordinances to keep their animals and the public safe. The Mammoth Lakes Police Department has responded to an increasing number of dog-related incidents and may issue citations for dog owners in violation of the following ordinances:

***MLTO 6.12.010 License (Required)*** – *If you live within the Town of Mammoth Lakes limits the owner of any dog over the age of six months shall procure a town dog license and pay thereafter an annual license fee for each dog.*

***MLTO 6.12.210 Dog at large*** - *It is unlawful for any person owning, harboring, or having the care, custody or possession of any dog within the town limits of Mammoth Lakes to allow such dog to run at large. All such dogs shall be kept securely fastened by a chain, rope or leash unless securely confined within private property legally controlled by the person in possession of the dog. Further, any dog off the premises of its owner, or the person charged with the care, custody or possession of the dog, shall be presumed to be at large unless it is securely fastened to a rope, chain or leash not exceeding six feet in length and is under the immediate physical control of a competent person.*

Pet ownership comes with the responsibility of humane care and management of their animal, along with a legal obligation as well. A dog owner is liable for a victim’s injuries if their dog bites and injures the victim. These ordinances also apply at Town parks and facilities. ### **Town Conducting Road Maintenance on Main Street**

The Town of Mammoth Lakes has contracted with Spiess Construction to reconstruct the retaining walls and construct new sidewalks along the north side of SR-203 from Minaret Road to Mountain Boulevard. Construction preparation will occur on North Main St between Mountain Blvd and Minaret Blvd. No traffic delays will be implemented until further notice. Still use caution and be aware of any workers within the site.

Work will be continue until November 2016 and will affect pedestrian and vehicular traffic. ## **Vacancies on Mammoth Lakes Mosquito Abatement District**

There are currently five vacancies for expired terms for the Mammoth Lakes Mosquito Abatement District to be filled by appointment of the Mono County Board of Supervisors. These five vacancies are for members of the Board of Trustees, which are appointed at-large for either two or four year terms at the Board of Supervisors' discretion, and will serve without compensation.

Qualifications for appointment:

- Voter in Mono County and resident of portion of Mono County within District;
- A member of town council may be appointed if meets other qualifications;
- Experience, training, and education in fields that will assist in the governance of the District; and
- Represents interests of the public as a whole.

### **Planning For a Safe Fourth of July**

Visitors planning to visit the Inyo National for the Fourth of July may require more planning than usual to have a safe and enjoyable visit.

The significant snowfall from this winter and the cool spring means that snow is still melting in many areas popular with visitors. Recent warm temperatures have led to substantial melt-off and flooding, closing other areas.

Many of the campgrounds that would be open for this weekend are either closed due to snow, flooding, or working through maintenance issues, such as water and waste water systems being energized and tested. This includes campgrounds in the Lakes Basin, Reds Meadow Valley, and Upper Lee Vining Canyon. Some campgrounds in the Lower Lee Vining Canyon are flooded.

Many roads are experiencing flooding, such as the North Lake Road, Onion Valley Road, and Monache Meadows. The Reds Meadow Road and the Saddlebag Road will not be open for the holiday weekend. In some locations, parking is very limited due to flooding or snow.

"I'd like to especially thank our employees and our partners with Inyo and Mono Counties, Caltrans, the Town of Mammoth Lakes, and the Mammoth Mountain Ski Area for their tireless work to open roads and facilities," said Ed Armenta, Forest Supervisor. "We understand how popular these areas are for our visitors. We will continue to work to safely open these locations, but we are seeing substantial damage from this past winter's snowpack and will likely continue to see more damage as the melt-off continues."

OHVers should anticipate and report storm damage they may come across on other roads on the forest. Please take care and verify depth before crossing swollen streams.

Backpackers and hikers should plan on snow levels around 10,000 ft., although this will vary between shaded and sun-exposed areas. Forging rivers, creeks and streams will be difficult and dangerous. Hikers should turn back if they cannot safely ford a waterway. Plan for mosquitos.

As a reminder, fireworks are never allowed on forest lands. Please enjoy one of several local fireworks displays offered by nearby communities.

### **Tioga Road in Yosemite National Park Open to all Vehicular Traffic June 29**

The Tioga Road in Yosemite National Park (Highway 120 through the park) opened for the season to all vehicular traffic on Thursday, June 29, 2017. There is limited visitor services available from the Tioga Pass Entrance Station to Crane Flat.

All visitors on the road are encouraged to use caution as there may be dirt, debris, and water flowing over sections of the road. Visitors are encouraged to keep an eye out for maintenance vehicles working on the roadway.

There will be minimal services available along the Tioga Road for several weeks. There will be no drinking water. Visitors should use the vault and portable toilets located along the roadway to help protect water quality in the Tuolumne River watershed. Food service and lodging are not available along the Tioga Road. There is no mobile phone service at this time and 911 emergency calls will not be operational. There are no gasoline services available along Tioga Road. Visitors can purchase gasoline in Lee Vining and at Crane Flat.

For maps and visitor information, visit the Tuolumne Meadows Wilderness Center, open from 8:30 am to 4:30 pm, the Big Oak Flat Information Station, the Yosemite Valley Visitor Center, and the Mono Basin Scenic Area Visitor Center in Lee Vining.

Tamarack Flat Campground is the only campground that is currently open along Tioga Road. This campground is first-come, first served and fills early in the day.

Anyone planning to hike or backpack near Tuolumne Meadows and in all high elevation areas of Yosemite should be prepared for winter hiking and camping conditions. Trails are still impacted by snow and ice. River crossings are high and swift moving. There are several high water areas currently impacting the Pacific Crest Trail (PCT) and the John Muir Trail (JMT) in Yosemite National Park. Trail conditions may vary at any time.

When driving in the park, motorists are urged to drive slowly as bears and other animals are active and may be present on the roadway. For updated 24-hour road and weather conditions for Yosemite National Park, please call 209-372-0200 and press 1.

### **Inyo National Forest Opens Lakes Basin Road**

The Inyo National Forest opened the Lakes Basin Road on June 21. While the road has been plowed, employees have continued with routine road maintenance such as filling pot holes and clearing culverts. They are still widening and opening parking lots covered in snow, placing dumpsters and porta potties, removing hazard trees and energizing water systems.

"I would like to acknowledge the tireless work of the Town of Mammoth Lakes maintenance crews, the forest's engineering and fire staff, and numerous others who have made the effort to open the Lakes Basin Road," said Jon Regelbrugge, Mammoth and Mono Lakes District Ranger. "It is no small feat to clear this area after this winter."

Horseshoe Lake remains closed. The area is still under snow, which traps the naturally occurring carbon dioxide. Additionally, the Old Mammoth Road to Lakes Basin remains closed with significant storm damage.

There is currently no potable water in Forest Service areas so visitors should bring water with them or may be able to purchase water from concessionaires as they open.

Visitors should expect significant snow still in the area, including on trails and on many popular recreation sites like campgrounds and marinas. Parking will be limited. Other areas may be flooded as snow melts.

Additionally, visitors should expect that the lakes are still partially ice covered. It is in no way safe to traverse the lakes. Creeks and streams are flowing at dangerous levels: please avoid them and keep close track of children and pets.

"While we welcome people to come and enjoy the beauty of the Lakes Basin area," said Shields Richardson, Mayor, Town of Mammoth Lakes, "please take care to experience the area safely."

### **Pedestrians and Bicycles on the Reds Meadow Road**

As of July 1, 2017, The Inyo National Forest is currently permitting pedestrians and bicycles to use the Reds Meadow Road. The road remains closed to cars and other vehicles except administrative traffic. The road had been previously closed for pedestrian and bike traffic for safety because of maintenance work, hazard tree falling, and other intensive work along the road corridor.

Those who walk/bike the Reds Meadow Rd. should be aware that maintenance work is continuing, at a diminished scale, and stop for or avoid road work. Bicyclists should understand that the road has not been swept. Rocks, limbs, and other debris on the road will present hazards for cyclists that will require extreme caution.

### **Inyo National Forest Closes Segments of Rush Creek Trails**

The Inyo National Forest, through a forest order, is closing segments of the Rush Creek Trail for public safety from June 30, 2017 through September 1, 2017.

The wet winter of 2016-2017, with more than 180% of average annual precipitation and close to 200% of average runoff forecast, has exacerbated safety concerns for dams within the Rush Creek Hydroelectric System (RCHS) on the Inyo National Forest. The extreme water year means water levels will likely exceed seismic safety ratings for a period of more than 25 days in Waugh Reservoir. The RCHS is currently operated by Southern California Edison under a license with the Federal Energy Regulatory Commission.

The forest order prohibits:

- Being within 800 feet of Rush Creek, from its intersection with the Waugh Lake Dam, then east to its intersection with Gem Lake, as shown on the attached map. 36 CFR 261.53(e).
- Being on the National Forest System trails listed below and shown on the attached map.
  - Rush Creek Trail from a point 750 feet north of its intersection with Clark Lakes Trail, then west to a point 528 feet west of its intersection with Weber Lake Trail.
  - Clark Lakes Trail from its intersection with Rush Creek trail, then south 1600 feet.
  - Spooky Meadows Trail from its intersection with Rush Creek Trail, then south to its intersection with the Ansel Adams Wilderness Boundary below Spooky Meadow.
  - Weber Lake Trail from its intersection with Rush Creek Trail, then south 1500 feet.

This closure affects access to popular destinations such as Thousand Island Lake, the John Muir Trail, and the Pacific Crest Trail. Visitors who hold a wilderness permit reservation made prior to June 30th for entry at the Rush Creek Trailhead should call the Wilderness Permit Office at (760) 873-2483 to cancel their reservation or reserve an alternate trailhead. The exception is for hikers (both day and overnight) whose

destination is Gem Lake or the Alger Lake Trail. Hikers, including PCT thru-hikers, cannot exit via the Rush Creek Trail and need to make alternate plans for exit and resupply.

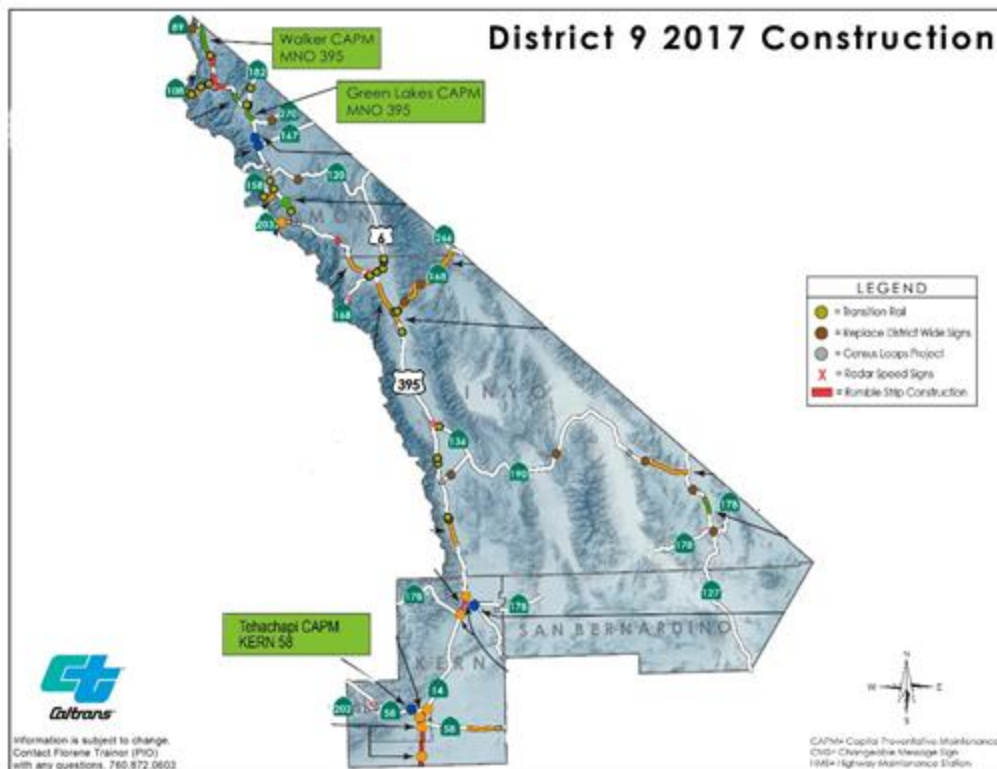
- Construction began on June 12, 2017 and will be completed by October 2017.

- The project location is in Mono County, from Eastside Lane in Walker, CA to the Nevada State line.
- Contractor is Road & Highway Builders, LLC from Reno, NV.
- Working hours: Mon – Thurs 6:00 am – 6:00 pm, Friday 6:00 am – 3:00 pm



- Traffic Impact during construction: Daily lane closures using reversing one-way traffic with flaggers at each location. Delays up to 20 minutes.

### **Tehachapi CAPM Project**

- Construction began on May 31, 2017 and will be completed by December 2017.
- Pavement preservation project.
- The project location is near Tehachapi from the Tehachapi Creek Bridge to Cache Creek Bridge.
- Contractor is Pave-Tech, Inc. from Vista, CA.

### **White Mountain Ranger District**

CARMA restoration area closure has moved. The main entrance gate on road 8S40 (east gate) to the restoration site will remain gated and locked. The western entrance of 8S40 is now open, allowing access to the roads 8S40B and 35E306. At road 35E306, road 8S40 is now gated and closed to motorized vehicle travel. The public is asked to respect the restoration efforts being made and not travel with motorized vehicles beyond the closed gates or park off of established roadways where vegetative seeding has occurred.

Roads open: McGee Creek Rd., Rock Creek Rd., Buttermilk Rd. (storm damage), Hwy 168 to Lake Sabrina, South Lake Rd., Big Pine Canyon (Glacier Lodge) Rd., White Mt. Rd one mile before Patriarch turn-off, Silver Canyon Rd., Wyman Canyon Rd. (expect difficult conditions).

Roads closed: North Lake Rd. (flooding), White Mt. Rd. one mile before the Patriarch Grove turn-off (snow).

### **Beware of Deer on the Roads**

The California Department of Transportation (Caltrans) would like to notify motorists that deer are out and about in the Eastern Sierra. Due to the snowy conditions, deer are venturing out onto the roadways to escape from the snow. Motorists should watch for deer as they are commuting especially during the dawn and dusk times of the day. Slow down and be vigilant!

*Ways to Prevent a Collision with a Deer:*

1. Slow Down. Motorists should take it slow especially with the low temperatures and icy conditions.
2. Watch for the rest of the gang. Deer are pack animals, and rarely travel alone. If a deer crosses in front of you, chances are there are more nearby. Slow down and keep an eye out for more deer darting across the road.
3. Timing is everything. Deer are most active at dusk and dawn: periods when your vision is most compromised. Slow down and stay alert, especially after dark.
4. Wear your seatbelt. It may not prevent a collision, but if the inevitable happens a seatbelt can reduce injuries.
5. Look. First, look for the road signs. The yellow diamond shaped signs with the deer on it are placed in high-traffic areas for deer. You may also spot a deer because their eyes will brightly reflect a car's headlights, making them easier to spot.
6. Stay Center. On a multi-lane road, the center lane is your safest bet for avoiding a deer collision, as long as your local traffic laws permit it. This gives deer plenty of space; and in case your vehicle does startle them, it gives you more time to react if one darts onto the road.
7. Stay the course. If you see a deer, brake firmly and calmly, and stay in your lane. Swerving could make you lose control of your vehicle and turn a bad situation much worse. Not to mention, deer are unpredictable, and you could swerve directly into their changed path.
8. Honk! Some experts recommend that one long blast of the horn will scare deer out of the road. Do not rely on hood whistles or other devices designed to scare off deer — studies have shown them to be largely ineffective at minimizing traffic incidents.

*What to do if you hit a deer.*

1. Pull to the side of the road as soon as it is safe to do so.
2. Turn on your hazard lights and remain in the vehicle until you are sure it is safe.
3. Call emergency services if injuries are involved or the local police for property damage.
4. Stay away from the deer. If it is still alive, it could be confused, injured and dangerous if approached. When contacting the authorities, let them know if the deer is in a dangerous spot on the road so that it can be removed.

### **Town Installs Hawk Signal in The Village**

The Town of Mammoth Lakes has installed a High-intensity Activated Crosswalk (HAWK) to improve pedestrian safety at the Minaret Road crosswalk adjacent to The Village. The HAWK signal is a pushbutton-activated pedestrian signal designed to aid pedestrian crossing at a mid-block crosswalk and reduce the amount of delay for vehicles. The HAWK signal differs from conventional traffic signals because it only becomes operational when activated by a pedestrian, allowing for normal traffic to flow unimpeded until pedestrians need to cross and minimizes wait time for vehicular traffic. Data suggests the pedestrian activated safety devices led to a 29% reduction in total crashes, a 69% reduction in pedestrian crashes, and a 15% reduction in severe crashes (2010 FHWA before-and-after study).

*What Drivers Should Know:* Pedestrian hybrid beacons are only activated by pedestrians wishing to cross a street press the signal button. If the lights of the beacon are dark, vehicles can proceed through the crosswalk. Flashing yellow lights usually last around three seconds, during which the driver should prepare to stop. A solid yellow light indicates the driver must stop. Once the light turns red, pedestrians will cross. Flashing red lights indicate that if there are no pedestrians in the walk, the driver may proceed through the walk with caution. After the flashing red lights, the signal will go dark again, and vehicles may freely pass through the intersection again. ### **Town's Owner-Occupant Housing Rehabilitation Program**

California Department of Housing and Community Development ("HCD") has awarded the Town of Mammoth Lakes a \$186,047 grant to administer a Housing Rehabilitation Program. Mammoth Lakes Housing, Inc. (MLH) as the "Program Operator," will administer the program. The funding may be used by property owners to update homes, attend to deferred maintenance, and address energy efficiency.

Property owners in Mammoth Lakes can benefit from this subsidy in the form of deferred payment loans, below market interest rate loans, and grants. Owners may use program funds to rehabilitate their home for the following eligible improvements:

1. **Correct health and safety issues;**
2. **Converting to current Uniform Building Code;**
3. **Energy conservation improvements;**
4. **Extension of useful life** (includes repairing siding, sheet rock, painting, new flooring, new cabinets, new interior doors, gutters and foundation upgrades and repairs); and
5. **General property improvements.**

To qualify for program funding, an existing homeowner must occupy the home and the household income must be equal to, or less than the following:

1 person	\$43,250
2 person	\$49,400
3 person	\$55,600
4 person	\$61,750
5 person	\$66,700
6 person	\$71,650
7 person	\$76,600
8 person	\$81,550

Units must be located within the Town of Mammoth Lakes in order to qualify for rehabilitation funds. General property improvements that enhance the overall exterior appearance of the property will be limited to 15% of the rehabilitation loan amount.

Funds will be allocated on a 'first come, first served' basis until all funding is exhausted. All interested Mammoth Lakes property owners are encouraged to immediately contact Mammoth Lakes Housing for additional information, eligibility requirements, and an application.

### **Would You Leave A Loaded Gun on the Floor?**

If you have children in your home, hopefully you would not! However, a new threat to the health of our children is emerging. These are e-liquids, sold legally in stores and online in small bottles that may be carelessly and casually left around the house, used for the regular re-filling of e-cigarettes.

The danger is from the nicotine content in these vials of "juice". Children can happen upon a vial and ingest it. These fluids come in flavors and bright colors that are attractive for kids – cotton candy, cherry, chocolate, and bubble gum among others. In addition, nicotine is absorbed through the skin, presenting a risk from a broken vial.

Electronic cigarettes, called e-cigarettes, are drug delivery devices originally designed to look like regular tobacco cigarettes. Now they are larger reusable gadgets that can be refilled with liquid, generally a mixture of nicotine, flavorings, and solvents. It is estimated that roughly four million Americans use these battery powered devices. They have been hailed by proponents as a way for addicted smokers to get their nicotine fix without sucking in the thousands of carcinogens found in traditional cigarettes.

However, the evidence of their effectiveness in assisting persons in weaning off their nicotine addiction is less than stellar. In addition, evidence is rapidly mounting that they are serving as a "gateway" for young teens into the world of nicotine addiction. A recent study found nearly 1.8 million youth had tried e-cigarettes, and the number of middle and high school e-smokers doubled in one year. No wonder the industry targets the young who will be potential customers for decades to come! Their goal – to have the number of e-smokers quadruple in the next few years.

So how bad is the risk of exposure? Nicotine is a naturally occurring powerful neurotoxin, and in its potent liquid form, can be ingested or absorbed through the skin. Tiny amounts can cause vomiting, seizures, and even death. A teaspoon of even the highly diluted liquid can kill a small child.

A dose of 50 to 60 milligrams (mg) is potentially fatal for an adult; a 30 pound child could die from 1.36 mg. A vial of e-juice as commonly sold in retail stores is 17 milliliters, and with a 2.4% concentration would have 408 mg of nicotine. This year it is estimated that 1 to 2 million LITERS of liquid will be sold, much of it on the Internet. A liter of 10% concentration costs about \$110, a gallon \$195, and one company even offers a 55 gallon drum!

Nationwide, reports of accidental poisonings linked to e-liquids in 2013 jumped 300% from 2012, and is on pace to double again this year. Most cases are under the age of 4. A shop owner says that "We tell them that this stuff is poisonous. We do everything we can to protect the consumers, but at the end of the day, you leave a loaded gun on the floor, and your child gets hold of it, it's not gonna be the gunmaker's responsibility." A CEO of e-cigarette franchises says "It's the wild, wild west right now." There is no FDA regulation so far. So at the moment, if you are a user, your child has to go no farther than your own home to find a lethal dose of poison. Be aware of the risks, and keep vials out of reach. You are responsible for the safety of your children.

### **Mammoth Lakes Police Department Implementing Reserve & Volunteer Program**

In an effort to off-set some of the impact resulting from the loss of 7 sworn officers, the Mammoth Lakes Police Department has been moving forward on developing Reserve and Volunteer Programs, and evaluating various forms of technology to help make the MLPD more efficient and effective. The following are some of the programs the MLPD is moving forward on:

#### RESERVE OFFICER PROGRAM

On February 6, the Town Council approved the establishment of pay scales for Reserve Officers. The pay will be:

- Level 1 Reserve - \$25/hour
- Level 2 Reserve - \$23/hour
- Level 3 Reserve - \$20/hour

Providing pay for Reserve Officers will make the MLPD competitive with other local agencies that have reserve programs and serve as a recruitment and retention tool.

#### VOLUNTEER PROGRAM

Many police departments benefit from active volunteer programs where trained volunteers assist police personnel by staffing front counters, completing reports, and providing community patrols. Retired Sergeant Karen Smart has agreed to manage the MLPD's volunteer program. At some time in the future, information will be released about the types of volunteer work available and the selection criteria. Anyone interested in volunteering with the MLPD should be on the look-out for a news release announcing the start of the program.

#### TECHNOLOGY

The MLPD is moving forward with technological advances on several fronts. They include:

- An on-line reporting system where certain crimes can be reported on-line.
- An on-line crime and traffic report purchase program where victims of crimes and parties in traffic collisions can purchase copies of reports on-line.
- Access to surveillance cameras at the North Village.
- Surveillance cameras at the Volcom Brothers Skatepark.

The MLPD is also exploring other technology that will make the Police Department more effective in addressing crime, the fear of crime, and quality of life issues.

### **Transient Occupancy Tax (TOT) Frequently Asked Questions**

Some of the most frequently asked questions about legal rentals and Transient Occupancy Tax (TOT) are:

#### **What is a transient rental?**

A transient rental is any unit that is occupied for the purpose of sleeping, lodging, or similar reasons for a period of 30 consecutive days or less in exchange for a fee or similar consideration.

#### **Can I rent my unit as a transient rental?**

Only some zones within the Town of Mammoth Lakes permit transient rentals. The following zones permit transient rentals:

- RMF-2 (Residential Multi-family 2)
- CL (Commercial Lodging)
- CG Commercial General)
- R (Resort, including master plan areas)
- SP (Specific Plan, including North Village and Clearwater)

This list is intended as a guide only. Although the above zones permit transient use generally, other regulations, such as those found in master plans, CC&Rs, or project conditions of approval may prohibit transient rental within a particular development. Generally, transient rental of single family homes is prohibited. A zoning map can be found on the Town's website.

### **What is transient occupancy tax (TOT)?**

Transient occupancy tax, or TOT, is a 13% tax that is charged "for the privilege of occupancy of any transient occupancy facility." The tax is required to be paid to the operator of the transient occupancy facility at the time the rent is paid. It is the operator's responsibility to remit the TOT to the Town.

### **Do I need to pay TOT?**

If you are renting your unit as a transient rental, even if it is only for one weekend a year, you need to pay TOT. This includes single family homes and other units that are not permitted to rent nightly, but may be doing so illegally. TOT shall be remitted for each night the unit is rented.

### **Do I need a business tax certificate?**

Yes, if you are renting your unit on a transient basis.

### **Do I need a transient occupancy tax certificate?**

Yes. You are required to purchase a transient occupancy certificate for each rental unit to post in your transient rental property. This is included as part of Schedule E or F in the business tax certificate application.

### **What is the difference between a business tax certificate and a transient occupancy tax certificate?**

Business tax is an annual tax and is required for all business activity. The transient occupancy tax certificate is a one-time purchase that is non-transferable. This certificate is required to be posted in your transient rental unit.

### **Do I need a business tax certificate if all of my rentals are handled through a reservation company?**

If all of your rentals are handled through a reservation company, most reservation companies will purchase the transient occupancy tax certificate and collect and remit the TOT to the Town. You may wish to check with your reservation company to confirm that this is being taken care of. If you rent your unit by owner in addition to renting with a property management company, you are also required to obtain a separate business tax certificate and transient occupancy tax certificate.

### **How do I apply for a business tax certificate?**

Transient Rentals fall under schedule F for condominium rentals and schedule E for hotels, motels, lodges, and campgrounds. This application can be mailed back to the Town, or submitted in person. The total cost for one unit is \$118.00 (\$65.00 application fee, \$5.00 planning review fee, \$25.00 fee to rent one unit, \$23.00 TOT certificate fee). Additional costs apply for additional units. Business tax certificates are required on or before the first day business commences; penalties will apply for late filings. If you have additional questions regarding this process please contact the Finance Department at (760) 934-8989 ext. 273.

### **Do I have a business tax certificate?**

To find out if you have a valid business tax certificate on file, please contact the Finance Department at (760) 934-8989 ext. 273 or your property management company.

### **What is illegal rental activity?**

Illegal rental activity is any rental activity that is not consistent with the Town's Zoning Ordinance, or any rental activity that is not compliant with the Transient Occupancy Tax Ordinance. This can include transient rental of units located in zones that prohibit transient rentals. It can also include transient rentals in a zone where it is permitted, but when the TOT is not remitted to the Town.

### **How can I report illegal rental activity?**

If you suspect illegal rental activity, you may submit an anonymous tip via the Town's TOT hotline at (760) 934-8989 ext. 275 or on the Town's website via the Transient Occupancy Tax information page. Please include any information that you have that would substantiate the claim, along with the property address and owner's name if you have it. You may also email [tot@ci.mammoth-lakes.ca.us](mailto:tot@ci.mammoth-lakes.ca.us). Note that emails are not anonymous, however, staff will do its best to keep your information private.

### **Town Outdoor Lighting Ordinance**

In 2003, the Town implemented an outdoor lighting ordinance to eliminate light pollution and preserve views of our starry skies. The outdoor lighting ordinance was adopted to encourage residents to administer a lighting system that not only promotes public safety and night-time ambiance but to maximize energy conservation. To eliminate glare and light trespass into neighboring properties and roadways, the outdoor lighting fixtures on your property should be shielded and re-directed to shine downward or changed out to a lower wattage.
